In response to the pandemic, we collaborated with partners in LA to create an initiative, which provided direct financial assistance to Angelenos. We provided \$36,753,800 via 37,841 "Angeleno Cards" to help 104,156 Angelenos. We then partnered with the Open Society Foundations for replication into 10 additional communities across the country, which have distributed over \$20,000,000 and helped over 30,000 people. In response to federal support in the American Rescue Plan (ARP), we are working with cities to establish Stimulus Command Centers, executive-level task forces comprising leaders from the public, private, and civic sectors that will serve as the points for planning, prioritizing, and coordinating federal rescue and recovery investments.
